Need to run a candidate by mid-March. Candidate discussions. Jesse and James to run for positions 1 and 5 respectively, currently held and being run for by Jeremy Lanthorn and Paul Bish. James needs to double check that he can hold both city council and school board positions simultaneously. James and Jesse will file and vote to be held next meeting on endorsements. Carol VonBorstel talked about FOIA requests regarding COVID/ESSER contracts/signatures regarding school board members.
