Agenda was presented by Travis West, chair. Motion from James Alley to approve the agenda, Josh Ball second. Agenda approved unanimously.

Reports of Officers:

Chair – Travis West

Travis briefed business as usual. Travis and James discussed their meeting with the Sherman County Republicans. Felt that it was a great meeting and that their organization was liberty focused and shared a lot of the same goals as the SCLP.

Unfinished and New Business

Firearm class-

Travis talked through his discussion with Salvos Training in The Dalles. Salvos has proposed 2x 2-hour sessions w/ 12 women. The sessions should be within 2-3 weeks of each other in order to maximize skills and knowledge retention, which will also allow them to return to the second session with questions. Salvos has an indoor range and would cover liability, waivers, and insurance. Cost would start at \$180 for the group. Question was asked whether Salvos would provide a kind of certificate (Travis will follow up). Discussed having a cost in order to have buy-in/commitment from participants. Travis suggested \$10 per participant. Josh recommended \$15 per person as it would offset entire cost.

Tack Sale Booth-

Josh talked through Tack sale. They had changed the name to "Western Market" so as to further widen the scope given the interest they garnered. The date was also moved to 18 March.

Recruitment-

Some mixed discussion. General consensus that local issues need to be addressed first and foremost. Also consensus that members of the SCLP should be pursuing local government and school board positions. Travis expressed the need to develop positive interactions between the community and SCLP.

School Board and Upcoming Local Elections-

Travis went through draft letter to School Board. Travis stated that Republican PCPs likely want to sign on to the letter. James asked about including PTO. State
